1. Welcome by Chairman Chairman called the meeting at 7.40 pm and welcomed all to the meeting.	
2. Review of 2011  Chairman gave a brief account of the main activities in the year 2011. A major change made was the re-scheduling of the two conference series organized by iSMARTi, namely the MAIREPAV and the ICTI conferences. Each of the two conferences will now be held on a 4-year cycle, held alternately in the even years. Another change was to have chairs of technical committees to be more actively involved in the technical program of the conferences. A major on-going activity was the preparation for the election of a new Board of Governors and Executive Committee to hold office from 2012 to 2015.	
The meeting noted that the election of the new Board of Governors and Executive Committee is overdue. The meeting decided that the Secretariat should issue the call for nominations by the the first week of February 2012, with the nominations to be closed by end February 2012. The election will be conducted electronically by the end of March 2012, and the new Board of Governors and Executive Committee will take office in April 2012. The current President Professor Paulo Pereira will chair the nomination committee.	iSMARTi Secretariat; Prof. Pereira
Members felt that iSMARTi must step up its activities to engage and interact with members. The meeting suggested that a task force committee be set up to work out strategies to revitalize iSMARTi. This matter will be taken up by the new Board of Governors.	New BOG

5.1. Mairepav7 – 2012, New Zealand	
Douglas made a progress report of the Mairepav7. The conference will be held at	
the University of Auckland from 28 to 30 July 2012. A total of 149 abstracts were	
received from 28 countries. Full papers are due in March 2012. Paper reviews are	
targeted to be completed by end of April 2012, and the revised paper are due by	
July 5, 2012. Three keynote speakers have been identified. They are Prof Andre Molenaar	
(DELFT), Prof Susan Tighe (Waterloo – CANADA), and Dr David Hutchison (Downer	
– New Zealand). Up to 4 parallel sessions are being planned. Each presentation	
will be allotted 20 minutes. Besides parallel technical sessions, there will be panel	
forums and poster sessions.
